# Information about how we process your personal information etc.

## 1. We are the data controller – how can you contact us?

## 3. Purposes of and legal basis for processing your personal information

We processes your personal information for the following purposes:

It is the duty of the Danish Road Traffic Authority to monitor the parking of vehicles on state highways. In the event of a violation of the rules of the Danish Traffic Code (Færdselsloven), the Danish Road Traffic Authority will issue a parking fine. Your information is processed in order to identify you and to subsequently enforce regulations, including charging you the parking fine. We subsequently process your information in order to document the parking violation.

#### The legal basis for our processing of your personal information arises from:

The Danish Road Traffic Authority monitors the parking of vehicles on state highways, cf. Sec. 121(1) Danish Traffic Code. Please also see Executive Order no. 1696 of 20 December 2018 regarding the Danish Road Traffic Authority's monitoring of the parking of vehicles on state highways. The Danish Road Traffic Authority has the authority to charge fines.

The Danish Road Traffic Authority may pass your case to the Danish Debt Collection Agency (Gældsstyrelsen) if the deadline for paying your fine has passed and the usual reminder

procedure has elapsed without success, cf. Danish Debt Collection Act (Gældsinddrivelsesloven). Unpaid parking fines issued by the Danish Road Traffic Authority shall be collected by the debt collection authority (Danish Debt Collection Agency), cf. Sec. 3 Executive Order no. 1696 of 20 December 2018.

The Danish Road Traffic Authority furthermore complies with the regulations of the Danish Administration Act (Forvaltningsloven) and the Danish Freedom of Information Act (Offentlighedsloven).

## 4. Categories of personal information

The categories of information which we process are general information and information regarding offences under the Traffic Code.

We process the following categories of personal information about you:

number plate, name, address, nationality, photo of vehicle, location, data, amount of fine, payment status, and information regarding the offence.

#### 5. Recipients or categories of recipients

We forward or transmit your personal information to the following recipients:

public authorities, owners of vehicles etc. in the country where your vehicle is registered. For foreign vehicles, the Danish Road Traffic Authority works with a UK company which carri

For foreign vehicles, the Danish Road Traffic Authority works with a UK company which carries out identification and enforcement activities.

The Danish Road Traffic Authority also uses data processors, e.g. for the electronic document and records management system where the Danish Road Traffic Authority stores and handles your case, and a fines system, from which the Danish Road Traffic Authority can retrieve all the information pertaining to fines that have been enforced.

If you fail to pay your fine by the declared deadline, the Danish Road Traffic Authority will pass your information to the Danish Debt Collection Agency for the purposes of debt collection.

# 6. Transmitting information to recipients in third countries, including international organisations

The Danish Road Traffic Authority's processing of personal data in connection with identifying persons and collecting fines issued to foreign vehicles may involve your personal information being transmitted to recipients outside of the EU and EEA. We do this insofar as the fine has not been paid in accordance with the ticket and a reminder procedure must be initiated in order to collect the debt.

The Danish Road Traffic Authority has partnered with Euro Parking Collection plc, a company located in the UK, which carries out the aforementioned activities for the Authority.

Transmissions to the UK are currently performed with respect to the Withdrawal Agreement between the UK and the EU.

If your vehicle is registered outside of the EU, we may transfer your information to your home country in connection with identifying you and collecting the debt. The basis for transmission is Art. 49(1) lit. d or e GDPR, cf. Art. 49(4).

#### 7. Where your personal information is obtained from

Information is collected using the number plate of the parked vehicle.

## 8. Storing your personal information

We are not currently able to say how long we will store your personal information for. However, we can inform you that we will take particular consideration of the regulations of the Administration Act, the Freedom of Information Act, and the Danish Archiving Act (Arkivloven),



including the principles of record-keeping and data minimisation, when determining how long your personal information will be stored for.

## 9. Right to withdraw consent

The processing of your personal information is not based on consent. You therefore cannot exercise this right with respect to the Danish Road Traffic Authority's handling of parking violations.

## 10. Your rights

According to the GDPR, you have a number of rights with respect to our processing of information about you. Please contact us if you would like to exercise your rights.

## Right to see information (right of access)

You have the right to see what information we are processing about you, as well as a number of additional pieces of information.

## Right to correction (rectification)

You have the right to have incorrect information about you corrected.

#### Right to erasure

In special cases, you have the right to have information about you erased before such time as our general rules of erasure come into effect.

#### Right to restriction of processing

In certain cases you have the right to have the processing of your personal information restricted. If you have the right to have processing restricted, we may only continue to process your information (not including storage) with your consent, where such is required for the establishment, exercise or defence of legal claims, or in order to protect a person or important public interests.

#### Right to object

In certain cases you have the right to object to our or the legal processing of your personal information. You can also object to the processing of your personal information for the purposes of direct marketing.

#### Right to transmit information (data portability)

In certain cases you have the right to receive your personal information in a structured, commonly used and machine-readable format, and to have this personal information transmitted from one controller to another without hindrance.
